Portland Streetcar Construction Advisory

Please be advised that **construction will begin the week of May 3, 2010** on the Broadway Bridge. Up to two lanes will be closed as crews prepare the bridge for the streetcar. Traffic will be restricted to 1 lane in each direction with height restrictions. Work will occur on the bridge through June 30, 2011 with a **Full bridge closure July 6—Sept 3, 2010**. (Construction subject to change).
